- > HHS Science Classroom/ Labs (Rooms 200, 202 & 204)
- HHS Media Center
- > HHS Elevator renovation
- Installation of Generators at all schools



## The Budget Process

- In late fall, our building Administrators and department leaders meet with the Superintendent and Business Administrator to discuss their budgets.
- In January and February, the district Administration along with the Finance Committee begin reviewing the budget and the district needs.
- The Finance Committee and Administration review state aid numbers, tax levy, projected revenues and possible cuts needed to balance the budget.
- The preliminary budget is then presented to the full Board of Education and discussed at a public work session. (March 6, 2023)
- Once approved by the full Board, the Budget is submitted to the Passaic County Office of Education on or before March 20, 2023, for approval.
- Budget Hearing and final approval of the 2023-24 budget on April 25, 2023.





#### **Historical Context**

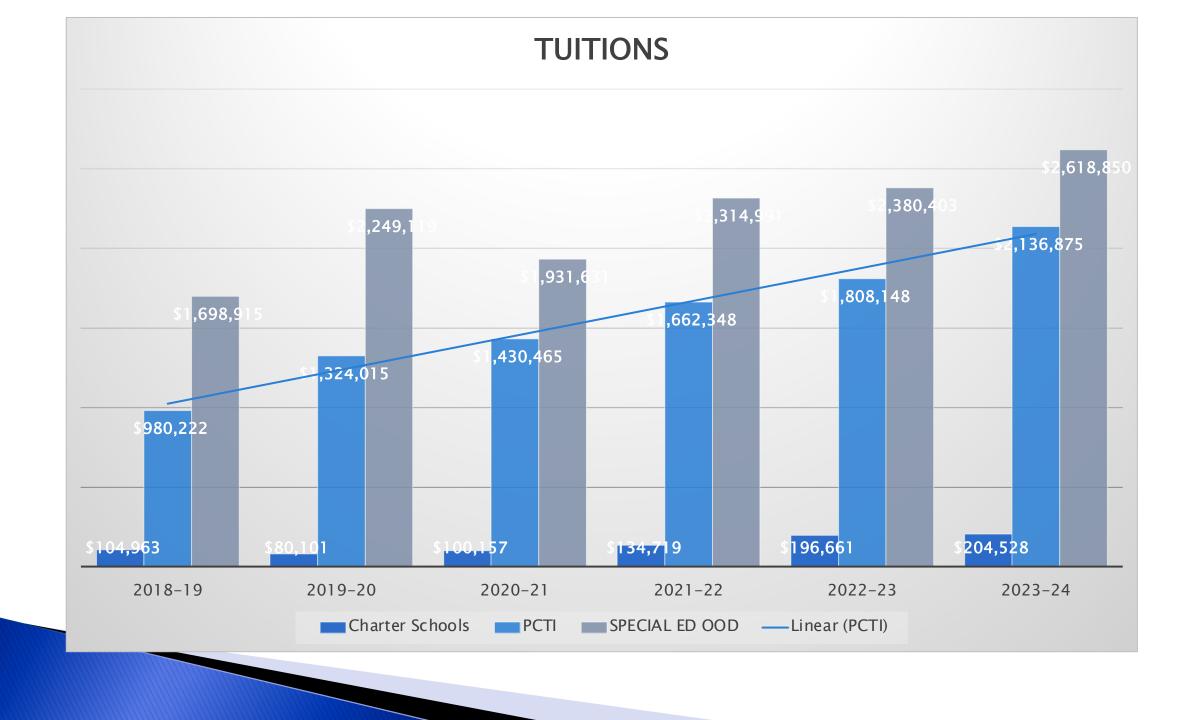
- In 2012, the Governor allowed districts to move from an April to November election without a budget vote as long as you kept your increase to 2% (or less)
- This new legislation did allow for some adjustments (Healthcare, enrollments, etc.)
- Since I arrived in 2015, this board has remained cognizant of their responsibility to the taxpayers of this community.
- Over the past eight years, the administration and board have requested only what was needed. To clarify....
  - 1 year at 2%
  - 3 years below 2%
  - 4 years over 2%
- 2% Increase for Hawthorne equates to: \$823,353
- Why would a school district need to go above 2%?

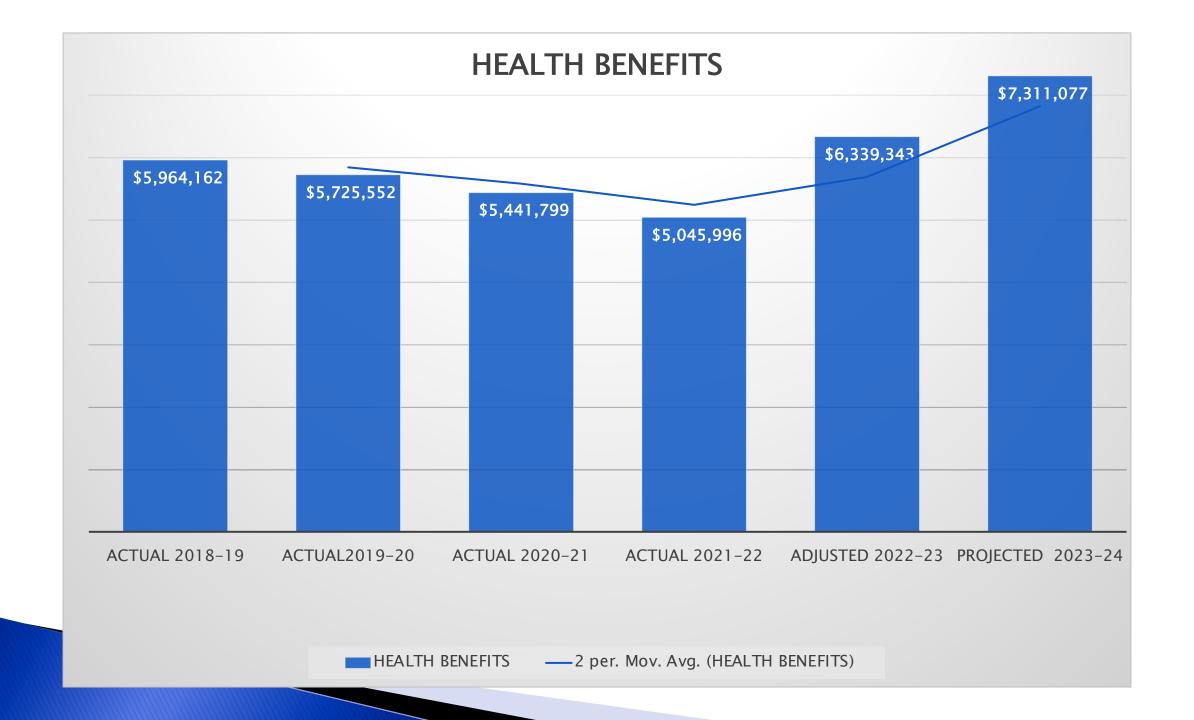




## **Challenges of Rising Costs**

- Record level inflation rates
- Nationwide Teacher, Paraprofessional, and Bus Driver shortages, which has increased costs for staffing and our outsourced bus routes
- As of January 2023, 15.1% increase in School Employee Health Benefits
- Increases in district security costs, out-of-district student costs, including PCTVS and Special Education (including busing)
- All of the above items create significant challenges for a budget with a
   2% CAP
- Examples of these increasing costs are as follows....







#### **Fiscal Efficiencies**

- Insurance consortium for liability and workers compensation insurance
- Statewide consortium to purchase internet access
- Bid consortiums for all instructional and office supplies,
   technology equipment, and special education transportation
- E-rate program for telecommunications
- Outsourced cafeteria services
- Shared service contracts for garbage, recycling, and school security with the borough





## **Supplementing Your Tax Dollars**

- Emergency Connectivity Fund (ECF) Billed Entity Applicant Reimbursement (BEAR) and E-rate reimbursements - \$219,488
- 2. The School and Small Business Ventilation and Energy Efficiency Verification and Repair ("SSB-VEEVR") Program grants totaling \$660,000
- 3. Capital Maintenance and Emergent Project Grant certification submission \$108,042
- 4. Regular Operating Districts (ROD) grant application for 40% (\$653,860) of anticipated project costs of partial roof replacements at Roosevelt Elementary and Lincoln Middle School
- 5. Community Oriented Policing Services (COPS) School Violence Prevention Program grant application for district wide PA communication system replacement with funding of up to 75% of costs to a maximum \$500,000

## **Tax Levy**



The statutory tax levy cap per N.J.S.A. 18A:7F-38 includes a 2 percent increase over the prior year general fund levy, plus allowable adjustments for enrollment increases, health care cost increases, deferred pension cost increases, etc.

Average Hawthorne home valued at \$381,026

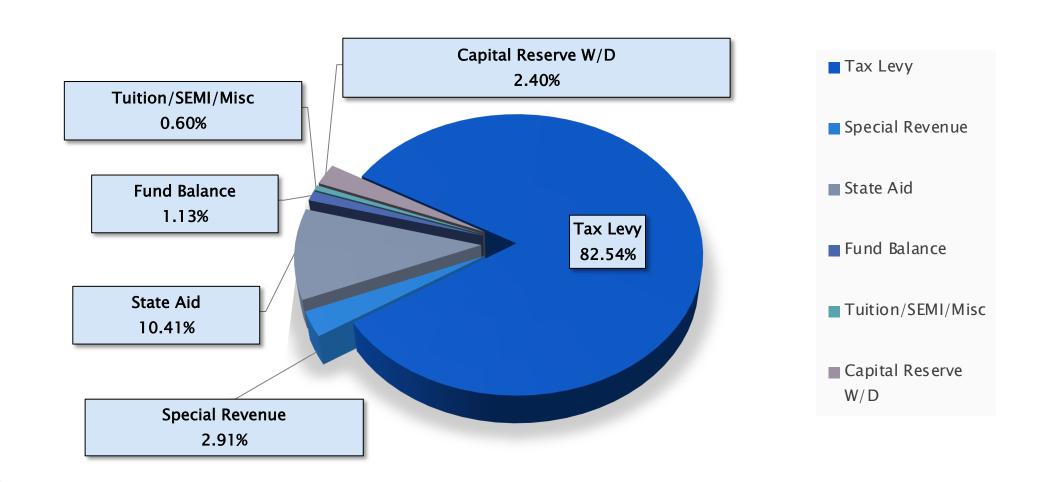
The tax increase from 2022/23 to 2023/24 is \$205.40 per year or \$17.11 per month

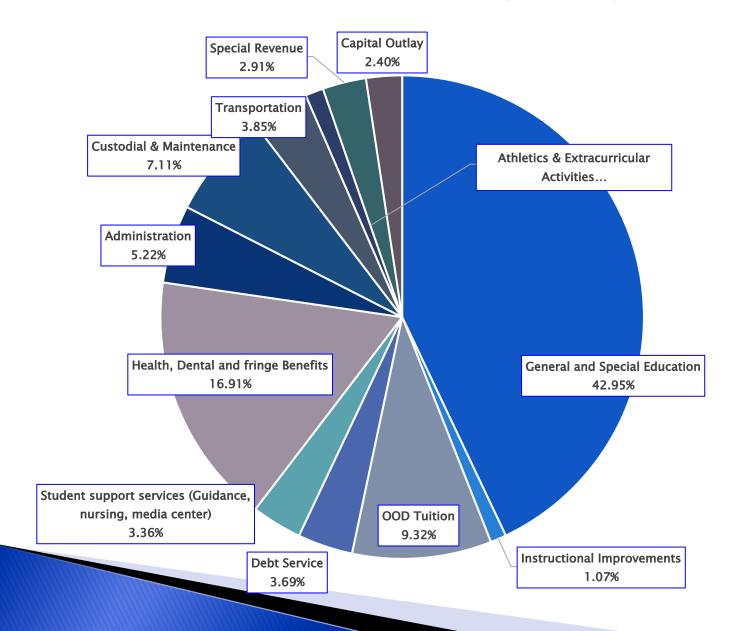

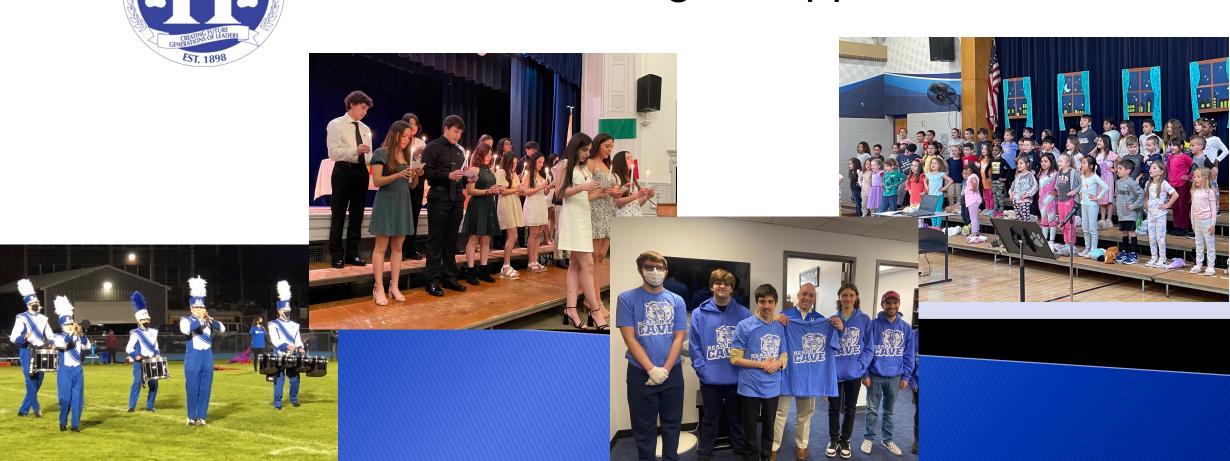

- New Ipads for our special education students in the elementary schools
- New district website to be introduced in January 2024
- Development of an E-Sports arena in the newly renovated HHS Media Center (includes building custom gaming computers)

- Maintain current academic programs and AP course offerings
- Supports the development of curriculum for the following new courses: AP Seminar, Rock Band, Behind Broadway, Songwriting, Exploration of Careers in the Trade Industry, Economics
- Supports curricular revisions for the following courses: English / Language Arts, Stem Process and Design, Coaching Principles, Sports Medicine, Healthy Choices for Student Athletes, Algebra I and II
- Provides continued professional development opportunities to all staff, including the summer AP institute for high school teachers







## **Curriculum and Instruction**

#### At the Middle and Elementary schools, the 2023-2024 budget will...

- Support the development of curriculum for the new Music Technology course at LMS
- Support curricular revisions for the following courses: *K-5 Research and Exploration, K- 8 English / Language Arts, STEM 7, and STEAM 8*
- Support the purchase of the new McGraw Hill WONDERS ELA program for grades K-5
- Provides for continued professional development opportunities to all staff, including Conquer Mathematics training and training for new ELA series
